### **INSTRUCTIONAL WORKLOAD POLICY**

#### **Non-Senate Instructional Unit**

The full-time Instructional Workload for this Unit is 9 Instructional Workload Courses (or the equivalent) per academic year.

This instructional workload assumes that the faculty-instructor may participate in governance and in professional and university service, and that routine, normal service of this type will normally carry an instructional workload course (IWC) equivalency of 0. Where such participation or service is assigned and carries a significantly heavier load, an instructional workload equivalency may be assigned.

A list of equivalencies specific to this academic unit is indicated below.

Where class size is a consideration in assigning workload, anticipated class size, not actual, will be the basis of instructional workload assignments.

There may be Instructional Workload Equivalencies not foreseeable at this time: these will be assigned on an ad hoc basis to the extent they appear to be one-time arrangements. Any that would appear likely to be repeated will require notification to UC/AFT and will be added to the formal Instructional Workload Policies.

#### 1. Equivalencies for undergraduate courses assigned by Department:

- a) Lower-division required courses with large expected enrollments (250 or more), unit values greater than four, substantial lab components, extended meeting hours, or more than four TAs assigned (ICS 21, 22, 23, 31, 32, 33, 51, 52): 1.5 IWC.
- b) Leading one discussion section: 0.5 IWC.
- c) Two-unit courses: 0.5 IWC.
- d) Other three- or four-unit courses: 1.0 IWC, except that courses with very large expected enrollments (200 or more) count as 1.5 IWC.
- e) Course offerings which for exceptional reasons have an unusually heavy workload may be assigned additional IWC credit at the discretion of the Department.

#### 2. Equivalencies for graduate courses assigned by Department:

- a) 398A, 398B: 0.5 IWC.
- b) Four-unit graduate courses that have a substantial lecture component: 1.0 IWC.
- c) Other graduate courses are not usually assigned to lecturers.

3. Each assigned duty other than teaching will have an IWC equivalency determined by the Department in the range of .25 to 1.5 IWC. Value to be assigned based on amount of anticipated work necessary to complete the assigned task.

Examples include:

- Curricular development
- Coordinating academic dishonesty detection systems such as MOSS
- IMPAC and articulation coordination
- Membership on certain assigned committees above and beyond normal expectations
- Overseeing potential lecturer pool
- Coordinating awards for students
- Advising - e.g., ACM Chapter, Programming Team, UGrad Computing Facility
- Serving as ICS TA Advisor
- Assisting deans and chairs with course scheduling
- Serving as resource and mentor on teaching issues for new, visiting, or adjunct faculty
- Participating in the preparation or administration of grant proposals or other projects
- Client management for courses with outside project sponsors
